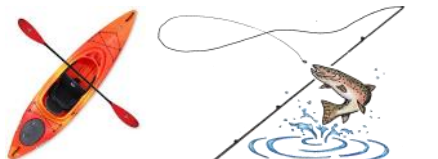

SHRINE CORNER

It appears the entire left side has been completed down to the patio. Weather has been cooperating and work has been able to be continued. I talked to Ron, who is doing the work, and he said they would like to go another 3 weeks. Now, I believe they are going to move to the right front face area. As the work on the left front face is down to the patio, replacement stone was running out.

Hearing the need for more stone, Joe G. took it upon himself to undertake obtaining more stone. Joe was successful and, along with Frank W. and Al H., drove up to Onaway to retrieve more pallets of the limestone. It is my understanding that an anonymous donor from the Parish purchased the stone. This purchase did not come out of the amount reported weekly in the insert. The work crew can continue to work, now that Joe, Frank and Al have come through in the clutch. It is also important to note that they are all K of C members.

Last Saturday, Maria Williams orchestrated a Rosary praying for our country on the 104 Anniversary of Fatima. It had originally been scheduled to be an open-air event, but, with high winds, it was moved inside.

Numerous visitors were in attendance including three Religious Sisters of Mercy from Saginaw. A good number of Parish members also attended. Joe G. led the Rosary and prayers, which included Benediction by Fr. San. Michelle H. did her usual spectacular AVE MARIA solo rendition, and you could hear a pin drop. At the conclusion, I took the Sisters of Mercy along with others on a tour. The good thing about tours on the weekend is that I can take them into the Pieta grotto (even though the candles and globes have been removed).

The Sisters of Mercy were given our information and will circulate it to other locations including the Bishop of Green Bay.

The Pieta statue has now been adopted. I am in the process of putting together pictures of the wall marble plaques that are currently in storage, but need repair. Once I review this with Fr. San, I will have a display board in the Narthex. These plaques were originally in front of the raised wall area in front of the Crucifixion scene. They have not been in place in the years I have been involved with the Shrine, so I am assuming most of you folks have never seen them either. They need to be restored and put back in place.

The Restoration Account is at \$95,776.72 and the Statute Reconditioning Account is at \$23,192.95.
